Tripping over Tempory cabling / equipment	<ul style="list-style-type: none"> • Risk of colliding with other objects and or people 	Low	All company	<ul style="list-style-type: none"> • All staff to be aware that there is Tempory cabling on the ground. • Equipment / cables no longer in use should be returned to a safe area • No cables to be moved without the knowledge of company artists. • No objects to be handled without the knowledge or consent of the company artists.

Physical exertion / strenuous movements.	<ul style="list-style-type: none"> Stress / strain / fatigue 	Low	All company members	<ul style="list-style-type: none"> Regular breaks will be called throughout the working day Cast to be trained in appropriate warm-up techniques, and time made available to do this before every rehearsal and performance. Any strenuous action within the performance will be blocked and supervised by a competent person.
Performing with hammers	<ul style="list-style-type: none"> Risk hitting another performer Risk dropping hammer Risk of cuts from saw Hammer heads detaching and flying off 	Medium	All users of space	<ul style="list-style-type: none"> All artists to receive appropriate training in the use of tools Work with tools to be thoroughly rehearsed Hammers used are the 450g – lighter than standard use hammers Tools not to be left in a hazardous position during the performance and to be stored safely when not in use. Hammers and brand new and only been used for the show. Hammerheads are tested to make sure they are secure before every show.
